## Tournament Rules: Please keep a copy of these rules for your use.

1. Tournament will consist of three games of 9-Pin No Tap Singles, by the following age divisions:

Women: Div. A: 75 - over, Div. B: $55-74$, and Div. C: 54 - below
Men: Div. A: 75 - over, Div. B: $55-74$, and Div. C: 54 - below
2. An entrant must be an adult member in good standing with the USBC. If not a member of SCCUSBC, entrant must provide an average verification from either their local association or bowl.com.
3. Bowler line-up must be listed on the entry form in the order that the bowler will bowl. No changes will be made except for substitutions.
4. Tournament shall be conducted on a handicap basis of $90 \%$ of 230 for men and $90 \%$ of 220 for women based on Rule \#5 that follows. All bowlers with an average above 230 for men and 220 for women will bowl scratch.
5. Averages - all averages must be 21 games or more. Averages will be taken in this order:
a. 2022-23 USBC certified highest average of all USBC leagues bowled from bowl.com.
b. 2021-22 USBC certified highest average of all USBC leagues bowled from bowl.com.
c. Current highest USBC certified average (must provide a league sheet).
d. If a bowler has none of the above averages, bowler will bowl scratch at 230 for men and 220 for women. Note: It is the participant's responsibility to verify accuracy of his/her average whether originally submitted by participant or others. Submission of a lower or false average could result in disqualification of the participant.
6. This tournament will enforce USBC Rules 319a-2 (10 pin increase in league average at time of bowling) based on highest average and 319c (Average Adjustments - Rerating) only.
7. It is the bowler's responsibility to verify the accuracy of their average whether originally submitted by the bowler or others. Failure to use the correct average may result in disqualification of the bowler's scores.. Refer to Rules 5 and 6.
8. A substitute bowler will be allowed for paid entries. Substitutes' averages subject to rule 5,6 and 7 .
9. Entry fee breakdown: Lineage $\$ 15.00$, Expenses $\$ 2.00$, Prize fund $\$ 18.00$ for a total of $\$ 35.00$. No refunds of entry fees with less than 48 -hour notice prior to start of scheduled squad time.
10. All prize monies will be returned $100 \%$. Prize ratio will be at least one prize for each 6 entries per division. Prize monies will be based on total pin fall plus handicap per division. All ties will be combined, and prize money divided evenly.
11. Multiple participation is allowed at this tournament - bowlers will cash with their highest series only. Bowlers may pre-register for more than one squad if they choose or walk-in on-site for any squad. Reminder: On-Site entries will be accepted based on lane availability.
12. Squads may be canceled or combined based on bowler participation.
13. Check-in is 60 minutes ( 1 hour) before scheduled time to bowl and each bowler must check themselves in. A bowler arriving late will receive zeros for all frames missed and may bowl with their score beginning in the frame that is in progress. Any bowler not checked in 10 minutes prior to the squad may lose their spot and entry fee will not be refunded.
14. All prize money won will be mailed (or delivered) to the individual bowler within thirty (30) days after the close of the tournament. An exception exists when USBC has authorized delay in payment pending settlement of any claim or protest which affects position standing. Checks will be mailed to the USBC membership card address on file.
15. The tournament officials shall have full power to act on any disputes or complaints. Any appeal or protest shall be made in writing within 72 hours per USBC tournament rule 329. Any rules not covered, shall be governed by the 2022-23 USBC tournament rules and regulations.
