



SANTA CLARA COUNTY USBC CRITERIA FOR RUNNING FOR THE BOARD

Santa Clara County USBC Association is looking for candidates to run for the 2024-2025 Board. Board members would be required to:

1. **Be a SCCUSBC member throughout their term**
2. **Complete the Safesport certification**
3. **Pass the Registered Volunteer Program (background check)**
4. **Attend monthly board meetings**
5. **Be available to work tournaments**
6. **Attend assigned committee meetings**
7. **Average time commitment each month is 15 – 20 hours.**

The description of duties for the positions open are as follows:

Vice President (2-year term) – Presides at all meetings when the president is absent; Performs other duties as prescribed by the board or president. Experience: two or more years as a SCCUSBC Director or Officer.

Sergeant-at-Arms (2-year term) – Is considered an officer of the association. Their main duties are counting votes, distributing/collecting ballots, time keeper and removing disruptive attendees from a meeting.

Director (3-year term) - Be an Ambassador to the Sport of Bowling; support the association's local fundraising and competitive tournaments; provide support and service to the members of the association. Experience: none needed, but knowledge of USBC rules and using Microsoft Office Products (i.e., Word, Xcel, Power Point) is a plus.

USBC Delegate (1-year term) – Represent the association members at USBC National convention; be prepared to vote on matters that are in the best interests of the association. Delegates may have travel and lodging expenses they may be responsible for. Experience: none needed, but must be a member of SCCUSBC.

State Delegate (1-year term) - Represent the association members at CA State convention; be prepared to vote on matters that are in the best interests of the association. Delegates may have travel and lodging expenses they may be responsible for. Experience: none needed, but must be a member of SCCUSBC.
