**Tournament Rules: Please keep a copy of these rules for your use.**

1. This tournament has a **2-person** (all men, all women, or mixed) **Doubles** and **Singles** format.
2. An entrant must be an adult member in good standing of the USBC. If not a member of SCCUSBC, entrant must buy a guest card for \$10.00 and provide an average verification from either their **local association** or **bowl.com**.
3. Bowler line-up in each event must be listed on the entry form in the order that the bowler will bowl. **No changes will be made except for substitutions.**
4. Each bowler will receive a handicap of 90% of the difference between the average and 220 in each event. All bowlers with an average above 220 will bowl scratch.
5. All Events will be figured with handicap - \$10.00 per person extra to enter All Events.
6. **Average must be 21 games or more and will be taken in this order:**
  - a. **2024-25** USBC certified highest average of all USBC leagues bowled from bowl.com.
  - b. Current highest USBC certified average of 21 or more games as of April 13, 2026 (must provide a league sheet).
  - c. **2023-24** USBC certified highest average of all USBC leagues bowled from bowl.com.
  - d. If bowler has none of the above averages, bowler will bowl scratch with a 220.
7. USBC Rule 319c (Average Adjustments – Rerating) will be applied for current averages that are 20+ pins higher than last year's book. If the assigned average is not accepted by the bowler, the entry fee shall be refunded. Rules 319a2 and 319d will be waived.
8. It is the bowler's responsibility to verify the accuracy of their average whether originally submitted by the bowler or others. Failure to use the correct average may result in disqualification of not only the bowler's scores but double partner's scores if the submitted average is incorrect. Refer to Rules 6 and 7.
9. A substitute is allowed. Rules 6, 7, and 8 (averages) will apply for substitute average. Paid All Events are not transferable unless a substitute replaces the original entrant in both events and the transfer is made by a tournament official prior to the substitute's participation in any event.
10. Dress Code: This is a Santa Clara County USBC championship tournament, appropriate attire is expected.
11. Entry fee breakdown (per event): Lineage \$16.50, Expenses \$1.75, Prize Fund \$21.75 for a total of \$40.00. All Events (optional) is \$10.00. Total to enter Doubles, Singles, and All Events is \$90.00 per person. **No refunds without notification to tournament management prior to the start of the squad.**
12. All prize money will be returned 100%. Prize ratio is at least one prize for each six (6) entries. All prize money will be based on total pins plus handicap.
13. Multiple participation is allowed in this tournament. In the Prize Distribution for multiple participation, all Doubles teams are eligible for tournament awards with different partners, but in Singles only the highest score will be eligible for an award. All Events is a combination of your scores for the first six (6) games of bowling your Doubles and Single events that will count towards the All Events score.
14. Squads may be rescheduled or canceled based on bowler participation.
15. Both Doubles and Singles events will be bowled with no more than three (3) bowlers to a lane (6 to a pair).
16. Check-in is 60 minutes (1 hour) before scheduled time to bowl and each bowler must check themselves in. **Any bowler not checked in 15 minutes prior to the squad may lose their spot and entry fee will not be refunded.**
17. Walk-ins and re-entries allowed based on lane availability, but must sign up no less than 30 minutes prior to the start of the squad
18. All prize money won will be mailed (or delivered) to the individual bowler within thirty (30) days after the close of the tournament except when the USBC has authorized delay in payment pending settlement of any claim or protest which affects position standing. Checks will be mailed to the USBC membership card address on file.
19. Any rules not covered, shall be governed by the 2025-26 USBC tournament rules and regulations
